

## **LRS Federal Project Description**

## **Project Management Support**

LRS Federal provides full-time, on-site support to conduct clinical and facilities Project Management services at Winn Army Community Hospital, Fort Stewart, GA. The Project Manager (PM) is required to be on-call and available to respond at all times in the event a problem or issue arises during ongoing field activities.

LRS is responsible for gathering input from facility departments, evaluating the overall common area



requirements, and making field surveys to investigate existing layouts and conditions. In addition, the LRS PM ensures individual projects conform to the applicable NFPA codes, Joint Commission on the Accreditation of Healthcare Organizations (JCAHO) standards, safety standards, and other agency criteria. The PM participates in on-site inspections of completed projects, providing input/recommendations as to acceptability/non-acceptability of completed work along with recommendations for corrective action when required. The PM coordinates with the facility infection control and safety officers to implement effective infection control and safety policies. The PM coordinates frequently with hospital staff to ensure proper project reviews and notification of utility outages. During utility outages, the PM is present to provide engineering and contractor support. The LRS PM attends and participates in pre-construction, staff meetings, in-progress reviews, and other project meetings. The PM frequently coordinates with the Facility Manager, Logistics, Medical Maintenance, Resource Management, the construction contractor, Directorate of Public Works, Corps of Engineers, and US Army Medical Command personnel.

The LRS QA representative was required to manage a difficult situation during the implementation of this project when the construction contractor failed to maintain adequate safety and quality assurance procedures resulting in a stop work order of the construction project. The LRS QA representative worked with the Mobile contracting staff and WRAIR personnel to assess the contractor's corrective action plans and identify alternatives required in the interim to provide steam to adjacent facilities.
